## **Gujarat Appropriation Act, 1965**

**4 of 1965**

**[30 March 1965]**

An Act to authorize payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Gujarat to the service of the year ending on the thirty-first day of March 1966. It is hereby enacted in the Sixteenth Year of the Republic of India as follows:-

### **1. Short Title :-**

This Act may be called the Gujarat Appropriation Act, 1965.

### **2. Issue Of Rs. 2,37,10,23,400 Out Of The Consolidated Fund Of The State Of Gujarat For The Year 1965-66 :-**

From and out of the Consolidated Fund of the State of Gujarat, there may be paid and applied sums not exceeding those specified in column. 4 of the Schedule hereto annexed amounting in the aggregate to the sum of Rs. 2,37,10,23,400 towards defraying the several charges which will come in course of payment during the financial year ending on the thirty-first day of March 1966 in respect of the services and purposes specified in column 2 of the Schedule.

### **3. Appropriation :-**

The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Gujarat by this Act shall be appropriated for the services and purposes expressed in the Schedule in

relation to the said year.
